## Possible mitigations and actions

Ask Member to do their own health assessment and stay away if:

- they have symptoms / feel unwell
- tested positive (PCR or Lateral flow)
- have been told to self isolate
- someone they have close contact with has tested positive
- are quarantining after a visit abroad

Encourage use of lateral flow tests

Encourage members to think about transport

Encourage vaccine take up

Someone becomes unwell at rehearsal (e.g. at a full day event):

- Person goes home and follows NHS procedures
- Anyone who had close contact goes home and follows NHS procedures
- Person with symptoms informs committee / close contacts of test results
- If positive inform wider attendees and venue

Rehearsal takes place outdoors

Doors and windows kept open as much as possible

Fans in corners of room

Use CO2 monitors to check ventilation quality

If CO2 above 1500ppm:

- take a break (everyone leaves the room)
- ventilate the room
- use face coverings

Room ventilated before rehearsals and during breaks

Regular breaks (every 30 minutes)

Overall length of rehearsal reduced

Use face coverings If desired

**HEPA filters** 

Venue cleaned before rehearsal / after last use

Hand soap / hand sanitiser provided

Regular Hand washing / sanitising encouraged

Toilets and common touch points cleaned regularly

Hand sanitiser provided at common touch points (e.g. doors, shared kitchen)

Members bring their own equipment (music stands, mics, sheet music, rosin, valve oil, wax, mutes, etc.)

No sharing of equipment where possible - hand sanitiser provided where unavoidable

#### Rubbish bins regularly emptied

Venue providing relevant Test and Trace information and check-in Register of attendees kept - informed if positive case reported

Risk assessment available online for all stakeholders to see 1 pager / simple instructions / expected behaviours sent to all members Posters at venue reminding of procedures (e.g. wash hands, social distancing, one way systems) Verbal reminders at rehearsals

2m social distancing at all times
